## **GENERAL TERMS AND CONDITIONS:**

- (i) The registration fees must be paid at the time the CARO Centre is seized and is non-refundable, even if the appointment process of the expert; mediator or arbitrator is not pursued. The registration fees shall be borne equally by the parties and be paid in full by the petitioner in advance. When several expert(s)/mediator(s)/arbitrator(s) are appointed, the Centre will charge the registration fees for each "neutral third party" appointed.
- (ii) The Fees and Expenses presented are estimated in Euros (EUR). Nevertheless, they may be paid in the following other currencies: USD based on the conversion rate in force on the day of introduction of the procedure (Article 2 of the OHADAC Rules for the Appointment of Experts; Article 3 of the OHADAC Rules for the Appointment of Arbitrators; Article 2 of the OHADAC Rules for the Appointment of Mediators).
- (iii) The Appointment fees are payable for the work done by the Centre during the appointment procedure, and include:
  - a. The proposal of one expert/mediator or arbitrator able to conduct the expertise, mediation or arbitration procedure;
  - b. The appointment of one expert/mediator or arbitrator able to conduct the expertise, mediation or arbitration procedure;
  - c. The possible replacement of the expert, mediator or arbitrator appointed as provided for in the applicable Rules for the appointment of expert/mediator/arbitrator.

If, in light of the circumstances of the case, the parties request the appointment of several experts/mediators or arbitrators, the amount of the registration fees and of the Appointment fees shall be multiplied by the number of appointed experts/mediators/arbitrators.

Fees and Expenses charged by the CARO Centre exclude the fees that will be charged by the appointed expert(s), mediator (s) and/or arbitrator(s). They also exclude counsel costs incurred by the parties; costs related to hearings, such as possible costs and disbursements in the case of the mediator's travel and accommodation, expenses, *etc*. The Centre will nevertheless be able recommend interesting solutions for the rental of conference rooms thanks to the network of Caribbean partners.

The CARO Centre's Appointment fees shall be paid in full at the time of the appointment of the expert, mediator or arbitrator by the Centre in accordance to the OHADAC Rules for the Appointment of Experts (article 7), the OHADAC Rules for the Appointment of Mediators (article 7) and the OHADAC Rules for the Appointment of Arbitrators (article 8).
