GENERAL TERMS AND CONDITIONS:

- (i) This schedule of costs is applicable to conventional mediation and court-ordered mediation, subject to the adaptation provided for at Article 3(4) of the OHADAC Mediation Rules.
- (ii) The amount at stake shall be determined on the basis of the cumulative amounts of the parties' financial requests.
- (iii) The registration fees must be paid at the time the CARO Centre is contacted and are non-refundable, even if the mediation process is not pursued. Half of the fees will be payable by each party and will be paid in full by the petitioner in advance. When several mediators are appointed, the Centre will charge the registration fees for each mediator appointed.
- (iv) On the basis of two parties to the mediation procedure, and one mediator appointed. If, in light of the circumstances of the case, the parties request the appointment of several mediators, the amount of the registration fees and of the administrative costs shall be multiplied by the number of appointed mediators.
- (v) The mediator's fees are exclusive of VAT. The mediator invoices VAT directly to the parties. When the mediation process goes beyond 8pm, the mediator's fees shall be increased of 20%.
- (vi) The administrative costs are estimated in Euros (EUR), on the basis of one mediator appointed. Nevertheless, the administrative costs may be paid in the following other currencies: USD, based on the conversion rate in force on the request date.

The administrative costs incurred by the Centre's due diligence during the mediation procedure include:

- a. The proposal of one mediator competent to conduct the mediation procedure;
- b. The appointment of one mediator;
- c. The financial management of the mediation procedure;
- d. The possible replacement of the mediator if he or she is no longer able to conduct the mediation in accordance with the Mediation Rules and applicable rules of deontology.

(vii) This total is estimated on the basis of two parties to the mediation procedure, and one mediator appointed.

Administrative costs and mediator's fees do not include room rentals nor possible costs and disbursements in the case of the mediator's travel and accommodation, expenses, *etc*. The Centre will nevertheless be able recommend interesting solutions for the rental of conference rooms thanks to the network of Caribbean partners.

The Centre's administrative costs and expenses and the mediator's fees shall be paid at the time of the appointment of the mediator by the Centre and non-refundable regardless of the outcome of the mediation procedure.
